- to undertake to comply with the University disciplinary regulations

- to release the accompanying teachers and the University from all responsibility for any unforeseen events or damage that may occur to oneself or to others due to conduct in breach of what was previously stated;
- to be informed that any inappropriate or harmful behavior can lead to exclusion from completing the external activity, to referral to the University Disciplinary Council and to the civil and criminal penalties provided for by the law.
- to have undergone a medical examination at the University doctor's office if the type and duration of the activity make it necessary

13. MEANS OF TRANSPORT

The University, during the entire Covid-19 emergency phase - and until otherwise agreed - will not provide its own means for the transport of people, as it cannot guarantee the spacing and therefore suitable safety conditions, the students who want to participate in the external activities must reach the locations provided by their own vehicle or by public transport

DECLARES
